A Letter From
Kirk Falconer
CEO, Destiny Rescue USA

Jesus said go and do like the Samaritan. While the Samaritan didn't know as much about the Bible as some experts, the commended, imperfect man did what he could to help someone with an urgent need. Then Jesus said he shared his money to fund the work that others could do. I trust that sounds familiar to you.

Most of us are called to stay right where we are, doing exactly what we're already doing including funding the rescue agents who find these kids who are being abused and the reintegration teams who are working on each child's unique Freedom Plan. I want you to know your investments are setting and keeping them free!

For 18 years, we have been on a mission to rescue children from sexual exploitation and trafficking. In 2019, in spite of being prevented from continuing to rescue in one of our seven project nations by a hostile government, we rescued an average of four victims per day--about two per day in raids, about one per day as they were being trafficked across a border, and about one per day in covert rescues by undercover agents that you sent! We have a lot to be thankful for.

It is impossible to account for the full, eternal impact of your investments. In addition to those rescued, countless young girls have been protected from being abused in the wake of 115 arrests in 80 successful raids. And for those young girls rescued as they were being

trafficked across the border, I have been to some of the brothels where these vulnerable girls would end their journey, and it is no exaggeration when I say "we" spared these young girls from hell on earth. Yet the most rewarding part of this work is seeing their smiles, crying with them, hearing their laugh or their testimonies, or celebrating their new job, marriage, or the birth of a child. They do smile again.

It is for freedom that we have been set free, and it is for freedom that we have rescued these kids. While every path to freedom is as unique as each of these young girls, our teammates on the reintegration team are keeping many of them free! Perhaps (said Mr. Obvious) Jesus was serious when he claimed that helping someone with an urgent need was how we "inherit eternal life."

Whether you became a monthly Rescue Partner, formed a team to raise the funds to Rescue A Child, inspired your church to host a Rescue Sunday, or invested in one of our project nations, you made this possible. By God's grace, you are one of the heroes of her story!

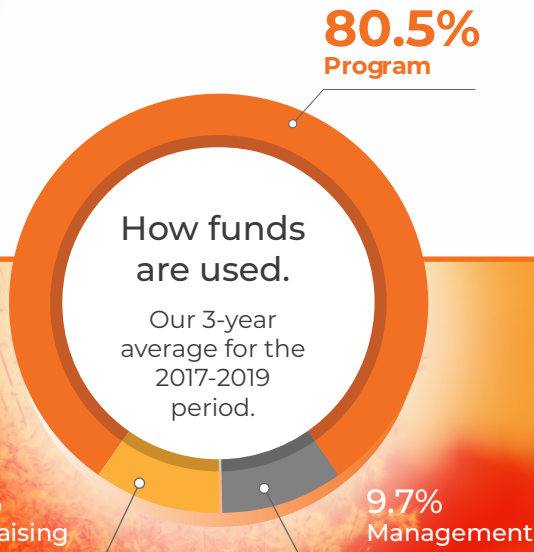
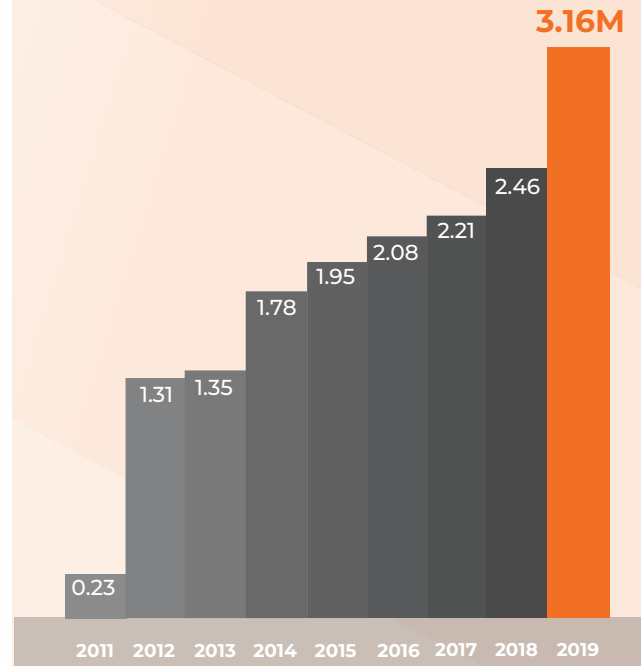
